

Public Wi-Fi Access Terms and Conditions

This agreement sets out the terms and conditions on which wireless internet access (“the Service”) is provided free of charge to you, a guest, vendor, board member or employee of the Kimberley Hotel Management Pty Ltd trading as Kununurra Country Club Resort (“KCCR”).

Your access to the Service is completely at the discretion of KCCR. Access to the Service may be blocked, suspended, limited or terminated at any time for any reason including, but not limited to, violation of this Agreement, actions that may lead to liability for KCCR, disruption of access to other users or networks, and violation of applicable laws or regulations. KCCR reserves the right to monitor and collect information while you are connected to the Service and that the collected information can be used at discretion of KCCR, including sharing the information with any law enforcement agencies, KCCR partners and/or KCCR vendors.

KCCR may revise this Agreement at any time. You must accept this Agreement each time you use the Service and it is your responsibility to review it for any changes each time.

We reserve the right at all times to withdraw the Service, change the specifications or manner of use of the Service, to change access codes, upload or download limits, usernames, passwords, or other security information necessary to access the service.

IF YOU DO NOT AGREE WITH THESE TERMS, INCLUDING CHANGES THERETO, DO NOT ACCESS OR USE THE SERVICE.

1. Disclaimer

You acknowledge
